Job Description:

Oversees Superfund Section sites for all phases of work, including site investigations, remediation, monitoring, and systems operations and provides engineering technical support on other Superfund projects for the Texas Commission on Environmental Quality (TCEQ). Conducts reviews of engineering design and remedial effectiveness, contaminant fate and transport, assessment methods, statistical evaluations, hydrogeologic evaluations, and compliance with human health risk assessment requirements, and/or other documents and provides written comments and directives in support of Remediation Project Managers or own assigned remediation projects. Oversees contracts, work orders, invoices, and project budgets to achieve corrective action at Superfund Section sites. Communicates with internal staff, the public, contractors, and other governmental entities. Represents the agency at site visits, technical functions, seminars, and meetings. Updates databases and maintains project files. Performs miscellaneous and/or special technical or administrative tasks as assigned. Attends technical and professional development training.

Texas Professional Engineer's license plus five years of full-time engineering experience beyond licensure.
Qualifying work experience includes that obtained post licensure as an engineering graduate student or teacher.

Special Requirements:

Moving up to 20 pounds of reports/office supplies and equipment.
Traveling up to 20% of the time.
Wearing personal protection equipment (Tyvek, boots, gloves).

Condition of Employment:
