12:45 Computer Equipment Recycling

Paul Munguia, TCEQ, talked about the computer law, enacted in 2008, requiring manufacturers who sell new computer equipment in or into Texas to provide a program for collecting and recycling of consumers' used computer equipment. Each manufacturer is responsible only for its own brand(s) of computer equipment. The collection and recycling must be convenient and free. Paul also noted that the first year of the law yielded 14.4 million lbs total collected.

1:35 Clean Texas

Memi Cardenas, TCEQ, talked about the Clean Texas program, the different membership levels of the program, examples of current members, and how to become a member. Fred Kelly, from 3M, talked about some of the things 3M is doing as a Clean Texas member. He also talked about going above compliance requirements to become a member, implementing an Environmental Management System, and the many benefits of being a member.
