

ORDER NO. 1

The preliminary hearing in this case was convened June 20, 2005. The Administrative Law Judge (ALJ) concludes notice was given in accordance with applicable statutes and rules and that the Texas Commission on Environmental Quality (the Commission) has jurisdiction over this matter. Synagro of Texas-CDR, Inc. (Synagro) and the Office of Public Interest Counsel (OPIC) are designated as parties to the case. The Protestants who were designated as parties by the Commission either have withdrawn their hearing requests as part of a settlement agreement or did not appear at the preliminary hearing.

As agreed, the hearing in this case is recessed until 10:00 a.m. June 30, 2005, to be reconvened at SOAH's hearing rooms on the fourth floor of the William P. Clements Building, 300 West 15<sup>th</sup> Street, Austin, Texas 78701. Before the hearing, Synagro and OPIC shall file pleadings indicating whether this matter may be remanded to the Executive Director for issuance of a draft permit in accordance with the settlement reached between Synagro and Protestants.
