

As you were previously notified, the Commission's Office of General Counsel has set the above-referenced matter for consideration by the Commission at its public meeting on **Wednesday, March 19, 2008**, starting at **1:00 p.m.** in Room 201S, Building E, 12100 Park 35 Circle, Austin, Texas 78753. The Commission will take oral argument on this matter. The Administrative Law Judge may speak first, with no time limit. The Applicant (Hidden View Dairy), the Hearing Requester (Lone Star Chapter of the Sierra Club), the Executive Director, and the Office of Public Interest Counsel (together, the Parties) may each have five minutes for oral argument, excluding time for answering questions raised by the Commissioners.

In addition, the Parties are hereby notified that they may file briefs or supplemental briefs with regard to the certified questions. All briefs and/or supplements must be filed with the Chief Clerk's Office no later than **5:00 p.m. on Tuesday, January 22, 2008**. The Parties may submit reply briefs, and any reply brief must be filed with the Chief Clerk's Office no later than **5:00 p.m. on Monday, February 4, 2008**. Filings should include an original and eleven (11) copies, reference the above-mentioned TCEQ Docket number, and be filed to the attention of the Agenda Docket Clerk, MC 105, P.O. Box 13087, Austin, Texas, 78711.
