Re: TCEQ Docket No. 2008-0860-WR: Motion to Overturn concerning the Executive Director's issuance of water right Permit No. 12225 to GSHS Customer Service Building 1, Ltd.

This letter is in response to the Motion to Overturn ("Motion") filed by GSHS Customer Service Building 1, Ltd ("Movant") on May 22, 2008. The Movant requests that the Commission overturn the Executive Director's issuance of Permit No. 12225 to the Movant because of discrepancies contained on Page 3 of the signed Permit. On May 27, 2008, the Executive Director filed a response recommending that the Commission grant the motion to overturn and issue a corrected permit to the Movant. After a review of the Motion and related briefs, the Commission's Office of General Counsel has determined to extend the time for the Commission to act on the Motion until **July 11, 2008**. The Commission's Office of General Counsel also has determined to set the above-referenced matter for consideration by the Commission at its public meeting on **Wednesday, July 9, 2008**, starting at **1:00 p.m.**, in Room 201S, Building E, 12100 Park 35 Circle, Austin, Texas 78753.

The Commission may take oral argument on this matter. The Movant, the Executive Director, and Office of Public Interest Counsel are hereby notified that oral presentations shall be limited to five minutes each, excluding time for answering questions raised by the Commissioners.
