A RESOLUTION Consideration of a Resolution to continue the Rio Grande Watermaster Advisory Committee. Docket No. 2009-1252-RES

WHEREAS, Section 5.107 of the Texas Water Code provides the Texas Commission on Environmental Quality and the Executive Director with the authority to create and consult with advisory committees; and

WHEREAS, Section 11.3261 of the Texas Water Code provides for the creation of the Rio Grande Watermaster Advisory Committee; and

WHEREAS, Chapter 2110 of the Texas Government Code states that an advisory committee is automatically abolished on the fourth anniversary of the date of its creation unless the governing body of the agency establishes a different date; and

WHEREAS, Commission rules at 30 Texas Administrative Code (TAC) Chapter 5 state that an advisory committee shall be automatically abolished in accordance with Chapter 2110 of the Texas Government Code; and

WHEREAS, the Commission resolution of October 14, 2005 continued the Rio Grande Watermaster Advisory Committee for four years.

NOW THEREFORE, BE IT RESOLVED BY THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY that the Commission hereby continues the Rio Grande Watermaster Advisory Committee until four years from the date of this resolution.

BE IT RESOLVED FURTHER that the commission affirms all standing appointments of members to the advisory committee continued and re-created by the resolution. Nothing in this resolution modifies any existing membership terms or offices.

Caption: Consideration of a resolution to continue the Rio Grande Watermaster Advisory Committee of the Texas Commission on Environmental Quality. The Rio Grande River Watermaster Advisory Committee provides recommendations to the Executive Director, comments on the annual budget, and performs various duties requested by the watermaster and water rights holders. (Section 11.3261 of the Texas Water Code).

Background

The Rio Grande Watermaster Advisory Committee was continued by the Commission by Resolution issued October 14, 2005. Commission rules at 30 Texas Administrative Code Chapter 5 state that an advisory committee shall be automatically abolished in accordance with Chapter 2110 of the Texas Government Code. Therefore, the Committee will be abolished October 14, 2009 unless the Commission acts to continue the Committee for an additional four years.

Action Requested

The Executive Director requests that the Commission continue the Rio Grande Watermaster Advisory Committee for an additional four years in accordance with the statutory mandate at TWC § 11.3261.
