Dear Mr. Shankle:

I would like to submit a formal request for a contested case hearing regarding the proposed Montgomery County landfill permit 2324. I, along with my constituents, stand in firm opposition to this proposed landfill.

As my constituents have previously stated, this landfill is unnecessary, unsafe, and an undue burden on the homeowners in East Montgomery County. This proposed landfill could have many adverse effects in this area of my district. There are drainage problems and heavy flooding in this area, and with over 150 shallow water wells in the area the landfill could prove to be a major health hazard. I would also like to point out that there is insufficient road infrastructure to handle the increased traffic that the landfill would bring. Walker Road, where the garbage truck would presumably travel, is a narrow road and serves as a bus route for school children. It is my opinion that the increased traffic brought on by garbage trucks would pose a danger to these children as well as Walker Road.

Please take my comments into consideration when deciding whether or not to grant a contested case hearing for this permit. Please feel free to contact my office if you need further information.
