Dear Sirs:

We request a public meeting on Permit No. 19933. The applicant is Border Steel, Inc., El Paso County, Texas. We suggest that the meeting be in Westway at Clinica La Fe or Deanna Davenport Elementary School. This meeting should be in both English and Spanish.

Border Interfaith (BI) is a non-profit organization composed of representatives of congregations and community groups in the El Paso, Texas area. BI is a broad-based community organization that works toward improving the quality of life for residents in the El Paso area. About six months ago, BI heard concerns of the residents of the Westway Colonia, some of whom were members of participating churches, about possible pollution from the Border Steel plant on the opposite side of Interstate 10 from the Westway Colonia. These concerns were also expressed by residents at a TCEQ hearing on landfill monitoring wells at Border Steel on June 23, 2005. Air pollution from Border Steel has been a topic at meetings in Westway attended by 30 to 40 Westway residents on July 15, 2005 and October 27, 2005.

We believe a public meeting is necessary for TCEQ to hear the concerns of the residents. The comment period of 15 days is much too short to allow meaningful written comments to be compiled. We would also request a 30-day extension of the comment period. There are unanswered questions about the permit renewal. The September 18, 1990 permit is based on consolidating Electric Arc Furnaces 1 and 2 into a single furnace with a net decrease in emissions. Since this has not been done and there is no indications that it will be, the basis for the permit is not valid. Both Permit 19933 and the new permit 73387 issued on August 26, 2005 specify low or no visible emissions past the plant boundary. Westway residents say that they see visible emissions frequently, but usually at night when TCEQ or resident's cameras cannot make a clear distinction of where and how extensive the discharges are. In addition, a few residents have noted deposition of a black substance on their cars in the morning.

Thank you for the opportunity to comment on the Border Steel application for an Air Quality Permit #19933.

We would urge the Texas Commission on Environmental Quality (TCEQ) to continue the requirement contained in Permit #73387 (Grandfathered Permit) to have no visible emissions from the EAF Furnace Building beyond the plant property boundary. We are concerned that the anticipated improvements in the processes at the plant, outlined in our meeting with Border Steel representatives in February 2006 do not appear to be progressing. Thus, the March 1, 2008 deadline in Special Condition 5 appears to be in question.

We urge the Commission to continue Special Conditions 3 and 4 of permit #73387 which deal with the allowable opacity from specific plant emissions. Residents of the Westway community are particularly concerned about the "smoke" coming from the plant.

We would urge the Commission to require stack monitoring. We are told that any monitoring, if performed at all, was done a long time ago. While measurements of the baghouse ash are an indication of pollutants removed, they do not provide verification of efficiency of the baghouse filters, nor do they give any indication of gaseous emissions. We are particularly concerned with the emissions of lead, nitrogen oxides, and volatile organic compounds (perhaps including dioxin and furans).

The Air Quality Modeling Analysis appears to be generally well done and comprehensive, at least within 5 kilometers of the plant. There are, however, two problems with the analysis.

The first problem is that the analysis uses weather data from 1988 from the El Paso International Airport. The Weather Bureau now has data from Santa Teresa, New Mexico which would be much more representative of the region around Border Steel. There is a 3000-foot mountain between Border Steel and the airport that influences wind patterns. The west winds, most important to the Westway community, would be predicted to be stronger than they actually are due to the down-slope effect on the east side of the mountains. Since the ground-level concentration of pollutants is inversely proportional to the wind speed, higher winds generally produce lower ground level concentrations. Thus the concentrations in the Westway area may be underestimated.

The second problem is the choice of a background location for nitrogen oxides. The measurements at Sunland Park, New Mexico are not representative of the plant area due to the presence of a major interstate highway next to the plant and to a truck stop with large numbers of trucks in the Westway community. We believe that the NAAQS for nitrogen oxides might be exceeded if the appropriate background concentration for this particular area were to be used.

We are also concerned that there is a history of noncompliance by Border Steel. In addition to several air quality incidents noted in 2005, Border Steel has been delinquent in filing annual reports, late in filing for permits, late in supplying needed information, and slow in supplying an acceptable Air Quality Modeling Analysis to the TCEQ for this permit. Border Steel has continued to operate with expired permits.

Thank you for the opportunity to comment. We look forward to improved air quality in the Westway area as a result of the new permit and to improvements to the process by Border Steel.
