I have been made aware that Lerin Hills, Ltd., has applied to your agency for a permit that would authorize the disposal of treated wastewater at a volume not to exceed a daily average flow of 500,000 gallons via discharge into an unnamed creek that will ultimately flow into Cibolo Creek. Residents in the area and downstream of the discharge have expressed concern about this permit application and its effect on the environment.

In light of the public interest in these proposed projects, I request that your agency hold a public meeting to give the applicant the opportunity to explain the project and for the residents in the area to voice their concerns about proposed permit #WQ0014712001.
