This is in response to a determination by the Attorneys for the Applicant, BFI Waste Systems of North America, Inc., that I should not be granted party status as my address is 6.58 miles from the facility. Ref: Table 3 – "Petitioners" Giving Addresses More Than One Mile from Facility, page 19.

Please be advised that *I am co-owner* of 98.7 acres located across from the BFI landfill at Bluegoose Road. ***This the property that is occupied by Cecil and Evelyn Remmert.*** A copy of the 2007 tax receipt is attached. I am requesting reconsideration as an affected person whose economic interest in this property will continue to be ***adversely affected*** by approval of the expansion request.

The property value has been and will remain lower than those of other properties in the county. A mountain of trash across from one's property is not appealing to a potential buyer who would be enduring odors, windblown trash, dust, noise from the operation of equipment 24 hours a day, ground water and surface contamination, and other environmental hazards which might come to light in the future.

I am opposed to the expansion request.
