Dear Sir/Madam:

Polk County Fresh Water Supply District No. 2's application for standby fees was received by your Districts Review Team on July 13, 2006. That team declared the application administratively complete on July 14, 2006. Due to this process your department asked for written reviews, due by August 15, 2008.

The following is a brief review of the Polk County Fresh Water Supply District No. 2 status:

1. Polk County Fresh Water Supply District No. 2 (the District) was created on January 26, 1976.
2. Among the Districts stated purposes are to:
 - a. Obtain and provide sewerage treatment services to the residents of the Onalaska Peninsula adjacent to Lake Livingston, and
 - b. Protect the health, safety, and welfare of the District's residents and the public downstream as related to malfunction of septic and other private sewerage systems, and the related pollution created by such systems.
3. The Districts provides wastewater, but not water, services in Polk County, Texas and is a municipal utility district operating under Code chs. 49 and 54.
4. The District obtained and forwarded the original document where upon Ted J. and Cora M. Watkins withdrew their protest to the application for Standby Fees (copy attached). This protest should be withdrawn due to this document.

The District is on Lake Livingston, therefore there are numerous property owners that have purchased property as long term investments. Standby Fees therefore assist to distribute a fair portion of the cost burden for operations and maintenance of the District's facilities to owners of

property who have not constructed vertical improvements but have wastewater services available. The District encompasses 5350.5 acres, with a small number of customers.

The District's residents consist of many elderly persons that have a very low monthly income. It is not possible to raise User Fees and taxes to properly fund operations and maintenance of the District's facilities to cover the cost burden. Once again, the undeveloped lots should contribute their fair portion of the cost burden for operations and maintenance.

Thank you for your assistance in the District's application being approved.
