We request a contested case hearing for the following reasons:

All parties on attached list live along the Petronila Creek in which this facility intends to discharge their treated sewer water. Number one reason to protest is that our properties are right on the creek and in most cases our property lines run into the middle of this creek, therefore making this proposal a dumping ground on property owned by us. Number two reason when it rains even 4 or 5 inches this creek overflows and runs within feet of our habitats. When this happens at 4 or 5 inches of rain one can only imagine what we dealt with when over 30 inches of rain fell in the month of July 2007. The brush growth into the creek from all properties of which none of us are financially able to clear out would certainly make for an unending flooding of our properties if this water is discharged into this creek. This would make our creek bordered properties unusable at any time not just when it rains. This also is not a flowing creek, meaning the water does not move. Therefore any additional water such as rain or in this case treated sewer water, the creek runs over its banks. In addition several of us fish in this creek and we have concerns about this. We also have park like areas on our properties very near the creek where we have barbeques and picnics and this doesn't seem very appealing to any of us.

We are not at all pleased with this and this was not discussed at the Town Hall meetings when this organization proposed to build their facility. They seem to have waited until they were well into construction of the facility to apply for this permit to discharge their sewer water into OUR creek.

Your consideration to hold a public meeting to discuss this will be greatly appreciated.
