The TRPOA was incorporated December 28, 1994, with the main purpose of protecting the membership's quality of life in regards to the land use, its value, and future. The State of Texas Charter number is 1338891. The TRPOA also acts to suppress any activities that are noxious, offensive, hazardous, or a nuisance to any tract owner. TRPOA has found that the proposed Backbone Creek MUD No. 1 presents a potential threat to its members' use and enjoyment of their property, as well as posing a threat to real property valuation.
