On behalf of Navarro Generating, LLC, I request a continuance of the Texas Commission on Environmental Quality's (TCEQ) scheduled May 19, 2010 public meeting to consider the hearing requests/requests for reconsideration on the above-referenced application. The reason for this request is that Navarro's Project Director, Mr. Chris Shugart, whose presence at the meeting is important, will be unavoidably out of the state on May 19. Navarro requests that the TCEQ continue the public meeting to June 30, 2010.

I have spoken to other counsel involved in this matter regarding their position on this continuance request. 
