Re: TCEQ docket number 2011-2287-WR & 2011-2288-WR


Included is a copy of the letter I received from Bentwood CC, dated May 2, 2012, giving notice of Bentwood CC's request to continue 2011-2287-WR to the July 25, 2012 Commissioner's meeting.

Is Bentwood CC proposing to separate 2011-2287-WR from 2011-2288-WR and meet on 2011-2288-WR at the planned May 16, 2012 meeting?

How would allowing Bentwood CC another 60 days to research the chain of ownership for adjudicated permit 1313, ownership information which the TCEQ records, and Bentwood CC surely researched before buying their portion of 1313, have any special bearing on Bentwood CC's request as contested in TCEQ docket number 2011-2287-WR & 2011-2288-WR?

Is Bentwood currently being given *special permission* to continue pumping from their proposed diversion point at Lake Nasworthy, under Bentwood's portion of permit 1313 and 1290-A, despite Bentwood's permit relocation request being contested?

The TCEQ must show neutrality and be cautious to not appear unfairly biased to the needs of golf courses over individuals and farmers. The TCEQ has a duty to deny Bentwood CC's continuance request and hear this issue at the scheduled May 16 meeting.
