Thank you for your July 19, 2012 email requesting a public meeting regarding the pending application by Rancho Viejo Waste Management, LLC for a Type 1 municipal solid waste landfill permit number 2374 in Webb County.

The Texas Commission on Environmental Quality (TCEQ) will be scheduling a public meeting regarding this application; however, on July 23, 2012, the TCEQ received a letter from the applicant requesting a 90-day delay for the publication of notice and application processing.
