

This matter is currently set for consideration during the Commission’s agenda meeting scheduled for August 5, 2015. Applicant now seeks a continuance, and asks that this matter be removed from the August 5 agenda and reset for consideration during the Commission’s agenda meeting scheduled for December 9, 2015.

This continuance is requested so that justice may be done and not solely for delay.
