To Whom It May Concern:

The Commissioner's Court of Wood County, Texas, as well as the Concerned Friends and Residents of Wood County, wish to express our environmental concerns regarding the Crutcher Tie & Lumber, LLC Proposed TPDES Permit # WQ0005120000. We sincerely request that TCEQ consider our issues during the review process. Furthermore, we request a public meeting or hearing prior to the final decision on the permit application.

Our concerns regarding the permit application are as follows:

- Environmental impact: Long term pathogens caused by the treatment process could irreversibly affect the ecosystem of the creek.
- Catastrophe: A surge or prolonged period of rain could cause the treatment system to overflow create greater erosion of the creek area.
- Economics: The reality or the perception of a contaminated creek could affect future county tax revenue by the abrupt termination of development.
- Preservation: It is imperative that this natural resource is protected for generations to come. While periodic testing may reveal immediate dangers, long term problems are impossible to predict.

We respectfully implore the TCEQ to honor our request and address our concerns to facilitate our retaining an environmentally safe area in Wood County, Texas.




