EXECUTIVE DIRECTOR'S MOTION TO REMAND

TO THE GENERAL COUNSEL OF THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY:

Pursuant to 30 Texas Administrative Code (TAC) Section (§) 10.4(d), the Executive Director of the Texas Commission on Environmental Quality respectfully requests that the Crutcher Tie and Lumber, LLC (Applicant) application for new TPDES Permit No. WQ0005120000, be remanded to the Executive Director. This matter is set for Commission consideration on the August 5, 2015 agenda meeting, and the deadline to file responses to hearing requests was July 13, 2015.

The only protestant in the case, the Wood County Commissioners' Court, withdrew its hearing request by a letter filed with the Office of the Chief Clerk on July 31, 2015. The Executive Director requests this remand because there are no remaining protestants in this case.
