Re: The Commission's consideration of a Motion for Rehearing filed by James and Shirley Martin regarding the Application of Farmersville Investors, L.P. for TPDES Permit No. WQ0014778001; TCEQ Docket No. 2008-1305-MWD; and SOAH Docket No. 582-09-2895

The above-referenced matter is scheduled to be considered by the Texas Commission on Environmental Quality (Commission) at its June 8, 2011 public meeting. On May 25, 2011, Farmersville Investors, L.P. filed an Agreed Motion for Continuance (Motion). The Motion explains that counsel for Farmersville Investors, L.P. (Farmersville) and for James and Shirley Martin (the Martins) will be out of state on June 8, 2011.
