This letter is to notify you that the Texas Commission on Environmental Quality (Commission) will consider Mizuho Corporate Bank MHCBC (USA)'s ("MHCBC's") appeal of the Executive Director's Negative Use Determination for Revised Application No. 8262, dated May 25, 2010 and all related filings during the Commission's public meeting scheduled to begin at **9:30 A.M. on Wednesday, August 25, 2010.**

During the public meeting, MHCBC, or its representative may speak first and save part of its time for rebuttal since MHCBC has filed the appeal at issue here.
