
Title 30 of the Texas Administrative Code, Chapter 50 authorizes an extension of time for taking action on the Motion up to 90 days after the date written notice of the Executive Director's action is mailed to an applicant. Accordingly, this letter shall serve as the order extending the time for the Commission to act on the Motion until **Friday, February 25, 2011**.

Micro Dirt, the Executive Director and the Office of Public Interest Counsel are hereby notified that they are encouraged to file response briefs with regard to the issues raised in the Motion. These briefs must be filed with the Chief Clerk's Office no later than **5:00 p.m. on Thursday, January 20, 2011**. Movants may file a reply brief with the Chief Clerk's Office no later than **5:00 p.m. on Wednesday, February 2, 2011**.

All responses and replies must be filed with the Chief Clerk of the TCEQ. Responses and replies may be filed with the Chief Clerk electronically under the procedures at <http://www10.tceq.state.tx.us/epic/efilings> or by filing an original and 7 copies with the Chief Clerk of the TCEQ. On the same day any response or reply is transmitted to the Chief Clerk, a copy must also be sent to each of the other parties listed on the attached mailing list, including the Movants, the Executive Director, the Public Interest Counsel, the Director of the Office of Public Assistance, and Micro Dirt. The General Counsel will consider all timely written filings on this matter and will inform the parties by separate letter if the Motion will be set on a Commission public meeting.
