

The Commission will take oral argument on the matters listed in the table above. Due to the overlap of issues presented in the appeals, the General Counsel is likely to recommend that the Commission take up the items together. In light of this, the fact that certain counsel represent multiple parties, and the extensive briefing that has already been filed on these matters, we request that the Appellants and the Appraisal Districts each coordinate to divide the time for oral argument. 
The above-referenced appeal (Appeal) was filed by Topaz Power Group, LLC (Appellant). The Appellant requests Commission consideration of the Executive Director's negative use determination for Use Determination Application Nos. 12210 and 12211. As is our general practice with regard to Use Determination appeals, this office is requesting the filing of legal briefs or responses to the Appeal by the Executive Director, the Office of Public Interest Counsel, and Nueces County Appraisal District; and the subsequent filing of a legal reply to the responses by the Appellant. The briefs should respond to the procedural and substantive issues raised in the Appeal and contain a full discussion of the parties' legal and factual reasons for their positions. Because briefs are also being requested on a number of other similar appeals and with the same briefing deadlines, the Executive Director, the Office of Public Interest Counsel, and other parties to multiple appeals may elect to file a consolidated brief that addresses multiple dockets. Any consolidated briefs should discuss the substantive and procedural issues unique to individual Appeals and the underlying use determinations, as well as those issues common to multiple dockets.

This letter is to notify the Nueces County Appraisal District, the Executive Director, and the Office of Public Interest Counsel that they may file a response brief in the Commission's Office of Chief Clerk (OCC) on or before **5:00 P.M. on Friday, August 8, 2014**. The Appellant may file a reply brief to the response briefs on or before **5:00 P.M. on Friday, September 5, 2014**. To be considered timely, an original and seven copies of any response or reply brief must be received in the OCC on or before the applicable 5:00 P.M. deadline. All briefs filed with the OCC should also be addressed to the attention of the Agenda Docket Clerk and be marked with the TCEQ Docket number provided above. All responses and replies must be filed with the Chief Clerk of the TCEQ. Responses and replies may be filed with the Chief Clerk electronically at [www.tceq.texas.gov/goto/eFilings](http://www.tceq.texas.gov/goto/eFilings) or by filing an original and 7 copies with the Chief Clerk of the TCEQ. All response and reply briefs should also be mailed to all other persons on the attached mailing list on the same day mailed or filed in the OCC. You will be notified by subsequent letter of the Commission public meeting during which the Commissioners will consider this matter.

Chapter 17 of the Commission's rules (30 Texas Administrative Code Chapter 17) set forth the requirements applicable to Use Determinations, including the rules that address the review standards and appeal process.
