**EXECUTIVE DIRECTOR'S REPLY TO MEADOW RIDGE FARM, LP'S AND HIGH  
POINT WATER SUPPLY CORPORATION'S JOINT MOTION TO OVERTURN THE  
EXECUTIVE DIRECTOR'S ORDER**

TO THE HONORABLE COMMISSIONERS:

The Executive Director (ED) of the Texas Commission on Environmental Quality hereby replies to Meadow Ridge Farm, LP's (Petitioner) and High Point Water Supply Corporation's (High Point WSC) Joint Motion to Overturn the Executive Director's Order (MTO) granting Petitioner's petition for an expedited release from High Point WSC's Certificate of Convenience and Necessity (CCN) in Kaufman County, Texas. The ED signed an Order granting Petitioner's request for an expedited release from High Point WSC's CCN area on May 28, 2014.

In the MTO, Petitioner and High Point WSC state that they have been involved in discussions regarding water service to Petitioner's land and believe that an agreement may be reached. Petitioner and High Point WSC request that the ED's Order be overturned to allow for further attempts to reach an agreement.

Both the Petitioner and High Point WSC have agreed to and jointly filed the MTO. The ED has no objection to granting the motion which will return the 418.3131 acres of Petitioner's property subject to the ED's Order to High Point WSC's CCN No. 10841.
