This letter is to notify you that the Texas Commission on Environmental Quality (Commission) will consider the above-described appeals and all related timely filings together during the Commission's public meeting scheduled to begin at **9:30 A.M. on Wednesday, April 1, 2015**.

The Appellants have five minutes for their oral presentation, including the time for rebuttal argument. The Chief Appraiser for the Grayson Central Appraisal District may speak next, followed by the Chief Appraiser for the Tax Appraisal District of Bell County (collectively "the Appraisal Districts"). The Appraisal Districts have five minutes for their oral presentation, to be divided amongst themselves. The Appraisal Districts should contact Meghan Taack, Manager for the Commissioners' Agenda Section, at (512) 239-3313 by 5:00 p.m. on Monday, March 30, 2015 to let her know how the time will be apportioned. The Executive Director will speak next, followed by the Office of Public Interest Counsel. The Executive Director and the Office of Public Interest Counsel will each have five minutes for their respective oral presentations.
