

On June 4, 2007, a Proposal for Decision (PFD) and Proposed Order were submitted for the consideration of the Texas Commission on Environmental Quality. On June 21, 2007, the Executive Director (ED) filed exceptions to the PFD and Proposed Order. On June 26, 2007, Doris Bullock filed exceptions to the PFD and Proposed Order.

The ED's exceptions dealt with typographical errors to conclusion of law no. 1 and ordering provision no. 2 and are not substantive. Ms. Bullock's exceptions dealt with substantive findings and included her comments on the weight to be accorded the evidence. After reviewing the parties' exceptions, the Administrative Law Judge recommends that you sustain the ED's exceptions and deny Ms. Bullock's exceptions.
