I am writing to you on behalf of Issa Ahmad. I received a certified letter from the TCEQ dated February 27, 2009 on Wednesday March 4. This letter informs me that the referenced matter is scheduled to be considered by the TCEQ on Wednesday March 11, 2009. I committed to another TCEQ related project on that same day and at the same time prior to receiving your February 27 certified letter. This conflicting project requires timely soil samples associated with a contested APAR and cannot be changed.
