Re: In the matter of an Enforcement Action against Al Jabour dba Rivers Country Villas and RV Park; TCEQ Docket No. 2005-1177-PWS-E; SOAH Docket No. 582-06-2366.

The above-named matter is currently scheduled to be considered by the Texas Commission on Environmental Quality ("TCEQ") at its September 19, 2007, public meeting. However, on September 11, 2007, the Respondent filed a motion requesting a continuance of this matter. The TCEQ Executive Director ("ED") and the Office of Public Interest Counsel ("OPIC") have no objections to the Respondent's motion. Accordingly, the TCEQ's Office of General Counsel, pursuant to 30 Texas Administrative Code §10.4, is continuing the above-named matter to the TCEQ's public meeting of **Wednesday, November 7, 2007**, beginning at **1:00 P.M.** The meeting will take place in Room 201S of Building E, 12100 Park 35 Circle, Austin, Texas.

Additionally, on March 19, 2007, the Respondent filed with the Chief Clerk's Office, a reply ("pleading") to the Administrative Law Judge's Proposal for Decision. The ED and OPIC do not object to treating the pleading as timely under 30 Texas Administrative Code §80.257(b) or its distribution to the Commissioners. Thus, the Respondent's pleading will be distributed as timely received.
