Re: Motion to Extend Time to File Exceptions and Replies filed by Galilee Partners, L.P. with regard to the SOAH Proposal for Decision and Order issued December 23, 2008; TCEQ Docket No. 2005-1686-DIS; SOAH Docket No. 582-07-2163.

On January 7, 2009, Galilee Partners, L.P. filed an unopposed motion requesting an extension of time to file exceptions and replies with regard to the Proposal for Decision and Order recently issued by the State Office of Administrative Hearings in the above-described docket numbers. The Movant states that currently the exceptions and replies to exceptions are due respectively by January 12, 2009, and January 22, 2009 respectively. The Movant explains its attorney's offices were closed over the holidays until January 5, 2009, and thus, the Movant, who is also the Applicant in this matter, requests an extension of the deadlines by ten days to January 22, 2009 and February 2, 2009 respectively. The Movant further explains that the attorneys for the Executive Director, the Office of Public Interest Counsel, Ellis County and Ellis Prairie Soil and Water Conservation District have been contacted and none of them object to the requested extension.

Section 80.157(b) of the Commission's rules authorizes the Commission's General Counsel to extend the time for the filing of exceptions and replies to a proposal for decision. After review of the Motion and the absence of any objection to the extended deadlines for the filing of exceptions and replies, I have determined to extend the time for filing exceptions to **5:00 P.M. on Thursday, January 22, 2009**, and the time for filing Replies to Exceptions to **5:00 P.M. on Monday, February 2, 2009**.

At this time, this matter has not been scheduled for Commission consideration during an open meeting. When it is so scheduled, you will be notified by subsequent letter from the Office of Chief Clerk. 


