By letter dated August 6, 2007, Ms. Angela M. Stepherson, notified the Administrative Law Judge, Sarah G. Ramos, that Mr. Bryn Meredith is now serving as co-counsel, and all correspondence to the City of Weston should be sent to him at Taylor, Olson, Adkins, Sralla & Elam, L.L.P. I have confirmed with the Commission's Office of Chief Clerk that he has been added to the official mailing list for this matter.

In that August 6, 2007 letter, Ms. Stepherson has also indicated that the City of Weston, the Applicant, intends to file a motion to delay Commission consideration of this matter for at least three months in order to allow new members of the City Council to become familiar with this matter and to make further attempts at settlement. In the interest of saving the City additional time to file the Motion for Continuance/Delay of Consideration with the General Counsel's Office, I have determined to grant the request for a continuance/delay in consideration to no earlier than the Commission's December 5, 2007 public meeting. However, I request that the City file a status report at least 30 days before December 5, 2007 informing my office and the Office of Chief Clerk if there is a need for any additional delay.

By letter dated August 1, 2007, Administrative Law Judge Sarah G. Ramos forwarded to my office a Request to Withdraw as a Party filed by Mr. Edward A. Town. In his request to withdraw, Mr. Town explains that he is currently the Mayor of Weston, and he formally requests to be withdrawn as a party to the opposition of the application.

I have reviewed the authority delegated to the General Counsel by rule and resolution, and no rule or resolution authorizes the General Counsel to act on the Request to Withdraw as a Party. Accordingly, the Request to Withdraw will be presented to the Commissioners along with the Administrative Law Judge's Proposal for Decision and related filings from the parties at the same time if this matter does not settle. All parties will be notified by subsequent letter if these matters are set for Commission consideration during one of its regularly scheduled public meetings.




