Re: Request for filing extension concerning the application of Texas Landing Utilities (Applicant); TCEQ Docket No. 2007-1867-UCR; SOAH Docket No. 582-08-1023.

The Administrative Law Judge's Proposal for Decision, filed on May 9, 2011, stated that all exceptions were to be filed no later than Tuesday, May 31, 2011, and any replies to exceptions or briefs must be filed no later than Friday, June 10, 2011. By correspondence dated May 27, 2011, the Office of General Counsel extended the time for filing of exceptions until Tuesday, June 7, 2011, and any replies to exceptions or briefs until Friday, June 17, 2011, based on an unopposed request submitted on behalf of the Applicant. The extension of deadlines applied uniformly to all parties.

On June 9, 2011, the Office of Public Interest Counsel filed its exceptions to the Proposal for Decision. The Office of Public Interest Counsel indicated that an interoffice error caused the missed deadline and requested an extension of time for filing its exceptions. The request further indicated that all parties were unopposed to the submission.

After review of the request for extension, I have determined to extend the time for the Office of Public Interest Counsel to file its exceptions until **5:00 p.m. on June 10, 2011**, pursuant to 30 TAC §80.257(b). The Office of Public Interest Counsel's exceptions will be included in the backup materials when the Commission considers the above-referenced application.
