Re: Request for Briefing Extension concerning the application of Aqua Utilities, Inc. A/K/A Aqua Texas, Inc. (Respondent); TCEQ Docket No. 2008-0767-UTL-E; SOAH Docket No. 582-09-2571.

The Administrative Law Judge's Proposal for Decision, filed on December 13, 2011, stated that all exceptions were to be filed no later than January 3, 2012 and any replies to exceptions or briefs must be filed no later than January 13, 2012. By correspondence dated December 21, 2011, Scott R. Shoemaker, on behalf of the Respondent, has requested an extension of time for filing its exceptions, to 5:00 p.m. on Friday, January 13, 2012.
