Re: Application of Las Brisas Energy Center, LLC for State Air Quality Permit No. 85013, HAP48, PAL41, and PSD-TX-1138; TCEQ Docket No. 2009-0033-AIR; SOAH Docket No. 582-09-2005.

This letter is in response to the request received on May 3, 2010 by David Frederick on behalf of the Coastal Cardiology Association, Dr. Gregg Silverman, the San Patricio Aransas Refugio Medical Society, and the Nueces County Medical Society (collectively, the "Medical Group"). That letter requests an extension of the time to file Replies to Exceptions to the Administrative Law Judge's (ALJ's) Proposal for Decision in the above-referenced matter. The Medical Group requests that its Reply to Exceptions, which were received by the TCEQ Chief Clerk via facsimile at 5:03 p.m. on April 29, 2010 and file-stamped on April 30, 2010, be considered timely.

The Medical Group indicates that it has conferred with the ALJs and the parties and that the ALJs, Applicant, Executive Director, Office of Public Interest Counsel, Sierra Club, Environmental Defense Fund, Texas Clean Air, LULAC, and Roger Landress are unopposed to the requested extension and that Mr. Manuel Cavazos III, the representative for Individual Protestants, does not object to the motion. The Medical Group indicates that attempts to confer with Protestant Clean Economy Coalition were unsuccessful at the time of its filing. However, neither Clean Economy Coalition, nor any other party has filed any brief in opposition of the requested extension.

Pursuant to 30 Texas Administrative Code § 80.257(b), this letter hereby extends the time for filing Replies to Exceptions to the Administrative Law Judge's Proposal for Decision until **8:15 a.m. on Friday, April 30, 2010.**
