The above-named matter is scheduled to be considered by the Texas Commission on Environmental Quality at its August 11, 2010 public meeting. On August 3, 2010, the Respondent, Mr. Eun Bok Lee requested that this matter be continued until October, 2010 or after. The request states that the Mr. Lee will not be back in the United States until the end of August, 2010.

The other parties to this matter were contacted in regard to their position on the request. The Office of Public Interest Counsel does not oppose the request. However, the ED also states that if the Commission determines to continue the matter, he requests that it be set on a public meeting in September.

Accordingly, this matter is hereby continued. As provided by 30 TAC Section 10.4(c), the Chief Clerk will send notice of the rescheduled meeting date to the parties no later than ten days before the meeting is to be held.
