Re: The Administrative Law Judges' Proposal for Decision and Proposed Order regarding the application of White Stallion Energy Center, LLC for Air Quality Permit Nos. 86088, HAP28, PAL26 and PSD-TX-1160; TCEQ Docket No. 2009-0283-AIR; SOAH Docket No. 582-09-3008.

This letter is regarding the deadlines to file exceptions and replies in the above-referenced matter. It has come to the attention of the General Counsel that some confusion may have existed regarding access to the website posting and the mailing of the Proposal for Decision and Proposed Order surrounding the July Fourth holiday weekend. The Administrative Law Judges' submission of the Proposal for Decision dated July 2, 2010, established the deadlines for the parties to file exceptions by July 22, 2010, and replies to exceptions by August 2, 2010.

After assessing the situation, I have determined on my own motion to extend the time to allow the parties to file exceptions no later than **July 26, 2010, at 5:00 p.m.**, and file replies to the exceptions no later than **August 6, 2010, at 5:00 p.m.** Accordingly, this letter shall serve as an order extending the identified deadlines in the above-referenced matter pursuant to 30 Texas Administrative Code §§ 10.3 and 80.257.
