

Re: ALJ's Proposal for Decision and Order concerning Earnest M. Teel; TCEQ Docket No. 2009-1612-PST-E; SOAH Docket No. 582-10-3449.

The above-named matter is scheduled to be considered by the Texas Commission on Environmental Quality (Commission) at its January 26, 2011 public meeting. On January 20, 2011, Lori Teel Harris filed a request on behalf of the Respondent for continuance of this matter to a Commission public meeting in March 2011.
