The Administrative Law Judge's Proposal for Decision, filed on July 26, 2011, stated that all exceptions were to be filed no later than Monday, August 15, 2011 and any replies to exceptions or briefs must be filed no later than Thursday, August 25, 2011. By correspondence dated August 11, 2011, Mr. William W. Thompson, III, on behalf of the Respondent, has requested an extension of time for filing its exceptions, to 5:00 p.m. on Monday, August 22, 2011 and replies to exceptions, to 5:00 p.m. on Thursday, September 1, 2011.
