Re: Request for Briefing Extension concerning the Appeal of Navarro County Wholesale Ratepayers to Review the Wholesale Rate Increase Imposed by the City of Corsicana, Certificate of Convenience and Necessity No. 10776; TCEQ Docket No. 2009-1925-UCR; SOAH Docket No. 582-10-1944.

The Administrative Law Judge's Proposal for Decision, filed on August 17, 2011, stated that all exceptions were to be filed no later than Tuesday, September 6, 2011 and any replies to exceptions or briefs must be filed no later than Friday, September 16, 2011. By correspondence dated August 22, 2011, Ms. J. Kay Trostle, on behalf of the City of Corsicana (Corsicana), has requested an extension of time for filing its exceptions, to Wednesday September 14, 2011 or later. The request indicates that counsel for Corsicana will be out of the office until September 14, 2011. The request further indicates that counsel for the Ratepayers and counsel for the Executor Director are unopposed to the extension. The Office of Public Interest Counsel has notified my office that they are also unopposed to the extension.

After review of the request for extension, I have determined to extend the time for filing of exceptions until **5:00 p.m. on Thursday, September 15, 2011** and any replies to exceptions or briefs until **5:00 p.m. on Monday, September 26, 2011**, pursuant to 30 TAC §80.257(b). This extension of deadlines applies uniformly to all parties.
