TO THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY:



1. MMUD supports and does not object to the Proposal for Decision. MMUD files this Exception for the sole purpose of proposing the surcharge amount for MMUD's rate case expenses of \$17,394.17. MMUD proposes that this amount be recovered as a monthly surcharge of \$5.41 to each water and sewer customer for one month or until paid.
