This letter is in response to the request submitted on July 20, 2011, by Kari Gilbreth, on behalf of the Executive Director ("ED") of the Texas Commission on Environmental Quality in the above-referenced matter. That letter requests an extension of time to file exceptions to the Administrative Law Judge's Proposal for Decision. The ED requests that the deadline for filing exceptions be extended to July 29, 2011. Further, the ED requests that the deadline to file replies to the exceptions or briefs be extended to August 8, 2011. The ED indicated in his request that the Respondents stated they would not oppose extending either deadline. The Office of Public Interest Counsel also did not object to the ED's request for extension of either deadline.

Pursuant to 30 Texas Administrative Code § 80.257(b), this letter hereby extends the time for filing exceptions to the Administrative Law Judge's Proposal for Decision until **5:00 p.m. on Friday, July 29, 2011**. Any replies to those exceptions may be filed no later than **5:00 p.m. on Monday, August 8, 2011**. Box 13087, Austin, Texas 78711 [Fax (512) 239-3311]. Exceptions and replies should be served on those persons contained on the attached mailing list on the same day the document is filed with the Chief Clerk. A separate letter will be sent on a later date by the Chief Clerk notifying the parties of when this matter will be set for the Commission's public meeting.
