Re: ALJ's Proposal for Decision and Proposed Order regarding the application of EOG Resources, Inc. for Air Quality Permit No. 95412; TCEQ Docket No. 2012-0971-AIR; SOAH Docket No. 582-12-6347.

This letter concerns the scheduling of oral presentations for the Texas Commission on Environmental Quality's (Commission) deliberation and decision on the above-referenced matter. As previously notified, this matter has been set on the Commission's public meeting scheduled to begin at 9:30 a.m. on **Wednesday, February 12, 2014**. The Commission's meeting will take place in Room 201S of Building E, 12100 Park 35 Circle, Austin, Texas 78753. 30 Tex. Admin. Code § 80.263 provides:

In proceedings where a judge has held a public hearing and has issued a proposal for decision or other report to the commission, all oral presentations before the commission shall be limited to five minutes each, excluding time for answering questions, unless the chairman or general counsel establishes other limitations. Before the commission meeting, the general counsel may allot time for oral presentations. Oral presentations and responses to questions shall be directed to the commission.

In recognition of the complexity of this case, the Office of General Counsel hereby extends the time for oral argument to eight (8) minutes for the Applicant and eight (8) minutes for the Protestants, collectively. The Executive Director's and Office of Public Interest Counsel's time for oral argument will remain five (5) minutes. The Protestants should apportion their eight (8) minutes among themselves prior to the public meeting, and contact Sandra Lopez Hernandez, Agenda Coordinator, Office of the Chief Clerk at (512) 239-3310 by **5:00 p.m. Monday, February 10, 2014** to let her know how the time will be apportioned. The Applicant may save some time for rebuttal, as it bears the burden of proof.

Furthermore, if the Commissioners need additional information, they may ask questions of the parties after oral argument is completed. In light of the oral argument time periods previously found sufficient in complex matters, and given the Commissioners' ability to question the parties and clarify any issues, the Office of General Counsel finds that the time period provided to the parties should be sufficient.
