Re: In the matter of an Enforcement Action against Yahya Jafreh a/k/a John Jafreh; TCEQ Docket No. 2012-0996-PST-E; SOAH Docket No. 582-12-7936.

The above-referenced matter is scheduled to be considered by the Texas Commission on Environmental Quality (Commission) at its September 4, 2013 public meeting.
