Item 1. APPLICATION BY SAM WOMACK for a permit (Proposed Permit No. 03351) to authorize the disposal of wastes and wastewater from a dairy operation. The dairy operation will consist of a maximum of 500 head in confinement. The dairy is on the north side of an unnamed county road, approximately one mile south of the intersection of Farm-to-Market Road 920 and Farm-to-Market Road 2210 in Wise County, Texas.

Item 3. APPLICATION BY PENNZOIL PRODUCTS COMPANY DBA PENRECO for an amendment to Permit No. 00377 in order to install and reflect the use of an outfall diffuser. The permit currently authorizes a discharge of treated wastewater at a volume not to exceed an average flow of 75,000 gallons per day plus intermittent flow variable discharges of stormwater runoff. The plant site is approximately 700 feet southeast of the intersection of Farm to Market (F.M.) Road 517 and Nichols Street in the City of Dickinson, Galveston County, Texas.

Item 4. APPLICATION BY ROY T. GREEN for a minor amendment to Permit No. 02247 to update the terms and format and to include a specific term of five years. The permit authorizes disposal of waste and wastewater from a dairy which consists of a maximum of 600 total head in confinement. The dairy is adjacent to a county road, at a point approximately 2.5 miles north and 2.5 miles east of the intersection of U.S. Highway 281 and State Highway 8 in Erath County, Texas.

Permit No. 10347-01 currently authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 1,300,000 gallons per day, which will be Outfall 101. Permit No. 10347-02

currently authorizes a discharge at a volume not to exceed an average flow of 450,000 gallons per day, which will be Outfall 01. The proposed amendment would limit the combined flow to 1,750,000 gallons per day, but allow Outfall 201 to discharge up to 1,000,000 gallons per day. The wastewater treatment facilities are on both sides of and adjacent to Mile 1/2 East Road immediately south of its intersection with North Mile 8 Road in Hidalgo County, Texas.

APPLICATION BY THE SABINE MINING COMPANY for a minor amendment to Permit No. 02538 in order to revise the requirement language contained in a provision concerning discharges from the retention ponds. The permit authorizes flow variable discharges of rainfall runoff and mine water plus a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 6,000 gallons per day, which will remain the same. The plant site is south of the City of Hallsville, bordered on the north by Farm-to-Market Road 968 and Interstate Highway 20 at their intersection and on the south by the Sabine River in Harrison County, Texas.
