Item 1. Consideration of an application by SAFETY KLEEN CORPORATION Wichita Falls for a Class 2 Modification to Permit No. HW50232 in accordance with 31 TAC Section 305.69. Safety-Kleen operates a commercial hazardous waste recycling facility located at 1606 Missile Road, in the City of Wichita Falls, Wichita Falls, Texas.

Item 2. APPLICATION BY DAVIS BAYOU SERVICE COMPANY for a permit (Proposed Permit No. 13627-01) to authorize a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 50,000 gallons per day from the Cypress Lakes Wastewater Treatment Facilities. The facility will serve the Cypress Lake Subdivision in Liberty County. The plant site is located 6000 feet north of State Highway 105, approximately 4.5 miles northwest of the intersection of State Highway 105 and State Highway 146, approximately 9.4 miles east-southeast of the intersection of State Highway 105 and Farm to Market Road 163 in Liberty County, Texas.

Item 3. APPLICATION BY ROCKDALE, SANDOW, AND SOUTHERN RAILROAD CO. for a permit (Proposed Permit No. 03522) to authorize a discharge of treated washdown water and stormwater at a volume not to exceed a flow of 14,000 gallons during any 24-hour period. The applicant proposes to operate a line haul railroad maintenance facility. The plant site is 2000 feet southeast of the intersection of Highway 79 and FM 1786 in the City of Rockdale, Milam County, Texas.

Item 8. APPLICATION BY F & S DAIRY for an amendment to Permit No. 03256 to authorize an increase in the number of head from 600 to 960 and to incorporate improvements constructed after the permit was originally issued. The dairy is on the south side of Farm-to-Market Road 219 approximately one mile east of the intersection of Farm-to-Market Road 219 and State Highway 281 in Hamilton County, Texas.

Item 9. APPLICATION BY HOECHST CELANESE CHEMICAL GROUP, INC. for an amendment to Permit No. 02891 in order to change from a permit authorizing only disposal by irrigation to a permit authorizing continued disposal by irrigation and a discharge of non-process stormwater. The proposed amendment would authorize an intermittent flow variable discharge of non-process stormwater via Outfalls 001, 002 and 003; increase the amount of land used for irrigation at Section 155 from 315 acres to 394 acres. Application rates for the irrigated land

shall not exceed 4 acre-feet/acre/year or a daily maximum rate of 13,000 gal/acre/date for each irrigation system. The permittee operates an organic chemicals production facility. The plant site is southwest of the intersection of U.S. Highway 60 and FM Road 2300, approximately 3 and 1/2 miles southwest of the City of Pampa in Gray County, Texas.

Item 10. APPLICATION BY J.M. HUBER CORPORATION for an amendment to Permit No. 00737 to authorize the addition of permit parameters and effluent limitations for Total Suspended Solids and Ammonia-Nitrogen and to replace the parameter of Biochemical Oxygen Demand with Carbonaceous Biochemical Oxygen Demand. The permit currently authorizes an intermittent flow variable discharge of storm water runoff commingled with treated domestic sewage, washdown water and utility water, which will remain the same. The applicant operates a carbon black manufacturing plant, using the furnace process. The plant site is south of IH-10, bounded by Cedar Bayou on the east and by the Southern Pacific Railroad tracks on the west, about five miles northeast of the City of Baytown in Harris County, Texas.

APPLICATION BY KLAAS TALSMA for an amendment to Permit No. 03145 to authorize an increase in the number of milking head from 850 to a maximum of 1,400 and to incorporate improvements constructed after the permit was originally issued. The dairy is on the south side of an unnamed County Road located approximately eight miles southeast of the intersection of U.S. Highway 281 and U.S. Highway 67 in the City of Stephenville and four miles north of the Community of Duffau in Erath County, Texas.

The dairy is 3.0 miles southeast of the intersection of U.S. Highway 180 and U.S. Highway 84 in Scurry County, Texas.

The dairy is six miles southwest of the intersection of Interstate 35 West and State Highway 174 (City of Burleson), one mile northeast of the intersection of County Road 1016 and County Road 914 in Johnson County, Texas.
