Item 4. APPLICATION BY RECOVERY AND RECLAMATION, INC. for a commercial Class I hazardous industrial waste management (Proposed Permit No. HW50352) to authorize permit operation of a container storage unit in conjunction with its battery recycling operations. The proposed permit would authorize an enclosed container storage unit to store a maximum of 110,000 gallons (500 tons) hazardous waste. Recovery and Reclamation recycles batteries by separating their components to become feed stocks for various manufacturers. Wastes to be managed at this facility are classified as ignitable, corrosive, toxicity characteristic and reactive wastes. facility is located on an 8.7 acre tract of land, approximately 500 feet west of Highway 17 and 1000 feet north of Interstate Highway 20 at 2001 Western Blvd., just outside the City of Pecos, Reeves County, Texas.

The facility is located one mile south-southwest of the San Jacinto Monument at 2027 Battleground Road in Deer Park, Harris County, Texas.

The wastes managed at this facility are Class I hazardous and non-hazardous industrial solid waste generated on-site from wood preserving operations. The industrial solid waste management facility is located on the northwest corner portion of a 344-acre industrial manufacturing complex, bordered by Mill Street on the south, Neil Pickett Drive on the west, Pine Valley Road and Borden Drive on the north and First Street on the east, generally within the incorporated limits of the City of Diboll, Angelina County, Texas.
