The rulemaking will also implement Section 182(f), which requires all SIP requirements that apply for VOC to also apply for emissions of nitrogen oxides (NOX). The Houston-Galveston-Brazoria (HGB) area was classified as severe for both the one-hour ozone NAAQS and the 1997 eight-hour ozone NAAQS. The rulemaking will also provide for alternative options for the fee obligation and baseline amount calculations. Major stationary sources are subject to paying a fee of \$5,000, as adjusted by the consumer price index, per ton in excess of 80 percent of a baseline amount of VOC or NOX (or both.) The fee is proposed to be due annually until the area is redesignated attainment or has three years of data demonstrating attainment. (Kathy Pendleton, Terry Salem) (Rule Project No. 2009-009-101-EN)
