The revisions also include provisions, as required by HB 3399, that the executive director shall waive eligibility requirements on a finding of good cause. The adoption would implement part of House Bill (HB) 3399, 82nd Legislature, 2011, Regular Session, relating to requirements for receiving an incentive grant under the Texas Clean Fleet Program. The revisions to Chapter 114, as required by HB 3399, incorporate changes and additions to the program eligibility criteria, including: changes to the number of vehicles that must be included in a grant and that may be awarded funding by the Commission; changes to allow a vehicle that has been leased or commercially financed to be replaced under the program; changes to the time period over which a grant-funded vehicle must be operated; and establishing criteria for decommissioning a vehicle or vehicle engine replaced under the program. In addition, the revisions include provisions, as required under HB 3399, that the Executive Director shall waive the ownership and use requirements for the vehicle being replaced, upon a finding of good cause. The proposed rules were published in the November 4,

Item 41 **Docket No. 2011-1221-RUL.**

Consideration of the adoption of a new Division 6, Alternative Fueling Facilities Program, Sections 114.660 - 114.662 of 30 TAC Chapter 114, Control of Air Pollution from Motor Vehicles, Subchapter K, Mobile Source Incentive Programs. The rulemaking implements part of Senate Bill 385, 82nd Legislature, 2011, Regular Session, relating to establishing the criteria for prioritizing facilities to receive grants under the Alternative Fueling Facilities Program. Facilities eligible to receive grants under the program include a facility to store, compress, or dispense alternative fuels in a nonattainment area. Under the program, alternative fuels are defined as a fuel, other than gasoline or diesel fuel, other than biodiesel fuel, including electricity, compressed natural gas, liquefied natural gas, hydrogen, propane, or a mixture of fuels containing at least 85% methanol by volume. Consideration for publication of, and hearing on, proposed amended Section 298.290 and new Sections 298.300, 298.305, 298.310, 298.315, 298.320, 298.325, 298.330, 298.335, 298.340, 298.350, 298.355, 298.360, 298.365, 298.370, 298.375, 298.380, 298.385, and 298.390 of 30 TAC Chapter 298, Environmental Flow Standards for Surface Water. The proposed rulemaking would implement House Bill 3 and Senate Bill 3, 80th Legislature, 2007, Regular Session, relating to the establishment of environmental flow standards included in a permit or amended water right in the river and bay systems consisting of the Colorado and Lavaca Rivers and Matagorda and Lavaca Bays, and the Guadalupe, San Antonio, Mission, and Aransas Rivers and Mission, Copano, Aransas, and San Antonio Bays. Additionally, the rulemaking will amend the schedule for the revision of standards for the Sabine and Neches Rivers and Sabine Lake Bay. (Ron Ellis, Robin Smith) (Rule Project No. 2011-059-298-OW)

Approve publication of, and hearing on, proposed amendment and new Sections of 30 TAC Chapter 298, Environmental Flow Standards for Surface Water, as recommended by the Executive Director, but with the following amendments: 1) Insert the following sentence on page 8 of the preamble at the end of the sentence that carries over from the previous page: "The final environmental flow standards may either be higher or lower than the environmental flow standards in this proposed rule and may include additional components such as more levels of pulse flows, an additional large inflow pulse to Lavaca Bay, and a narrative standard for inflows to East Matagorda Bay consistent with the recommendations of the Stakeholder Committee. The Commission invites comments on all aspects of the full Stakeholder Committee recommendations."; 2) Insert the following paragraph on page 15 of the preamble between the first and second paragraphs of the section entitled "Section 298.330 Environmental Flow Standards": "The stakeholders expressed strong concern about the reduction of freshwater inflows to East Matagorda Bay. The stakeholders adopted the following statement: 'Strategies to maintain and increase freshwater inflows should be pursued to support a sound ecological environment within East Matagorda Bay.' The stakeholders intent was to avoid a further reduction of the freshwater inflows, to the extent those reductions can be avoided, and that strategies should be pursued to provide additional freshwater inflows to East Matagorda Bay."; 3) Insert the following sentence on page 22 of the preamble at the end of the last sentence of the first paragraph: "The final environmental flow standards may either be higher or lower than the environmental flow standards in this proposed rule and may include additional components such as additional levels of base flows at locations on the Guadalupe River and its tributaries, and additional levels of pulse flows consistent with the recommendation of the Stakeholder Committee. The Commission invites comments on all aspects of the full Stakeholder Committee recommendations."; and 4) Replace the word "and" at the end of 30 TAC Section 298.330(a)(1) with the word "or". CR/BG; all agree.
