Grant the hearing request of Suzanne Zick; Deny the remaining hearing requests; Refer the matter to the Commission's alternative dispute resolution program concurrent with the SOAH scheduling process; Refer the matter to SOAH for a contested case hearing on the following issues: 1) Whether the draft permit is protective of the air quality, the requestor's health and wildlife and 2) Whether the applicant performed and submitted in the permit application accurate emission calculations and dispersion modeling; and Specify a maximum duration of the hearing of six months from the preliminary hearing to the issuance of the proposal for decision. JN/TB all agree.

WATER USE PERMIT APPLICATION MATTERS

Consideration of an application by William Gavranovic, Jr. (Applicant) to extend or delete the term authorization for diversions under Water Use Permit No. 5603. The permit authorizes the diversion and use of 4,350 acre-feet of water per year, being 850 acre-feet from the Old River and 3.500 acre-feet from the Brazos River. Brazos River Basin for agricultural use in Burleson County. The authorization to divert 4,350 acre-feet expired on December 31, 2008, and the Applicant timely requested an extension or deletion of the term and to reduce the diversion amount to 3,210 acre-feet of water per year, divided as 620 acre-feet from the Old River and 2,590 acre-feet from the Brazos River. The Executive Director recommends denial of Application No. 5603A because unappropriated water is not available for a perpetual authorization and appropriated but unused water is not available for extension of the term authorization. The Commission will consider the application, the ED's recommendation, and timely filings on this application. (Calvin Clary, Ruth Takeda)

Deny the application filed by William Gavranovic, Jr. concerning Water Use Permit No. 5603; and Issue the Executive Director's Proposed Order. TB/JN all agree.
