To Whom It May Concern:

We own the property located at 3227 CR 428, Stephenville, TX 76401 and as a result received a letter from the TECQ concerning the property at 2626 CR 428, Stephenville, TX 76401. Mr. Vander Horst is planning to operate a CAFO with up to 1525 head of cattle. **We are protesting this.**

When we bought our property on 428, there were two old dairies (one located across the street and one adjacent to the south) that had been closed for years and we understood that no one would be allowed to have cattle in either place in concentrated numbers. Mr. Vander Horst is currently operating a heifer grow yard at both locations. He has cattle stacked in there. The smell is nauseating and the flies are terrible. We have complained to Mr. Vander Horst. Now we are trying to sell our property and most potential buyers get out of their vehicle, smell the stench, and leave without even looking at the property. We feel that our property has been significantly devalued by this.

Our daughter Katey currently lives on the property and her job is a rodeo athlete. She must spend hours outdoors in preparation for her competitions. Again, the smell and flies are terrible. She spends time and money trying to control the hordes of flies that potentially carry illnesses to her livestock.

We request a contested case hearing.

Have your guidelines been updated for a densely settled area such as this area is?

Our main concern is the permitted 1,525 head = 5+ times the amt. there now. This could/would result in:

- 5 times the odor
- 5 times the flies

Since your guidelines do not live up to what they are designed to do, I request reconsideration of that large amount of 1,525 head. Many future problems could be prevented with your more careful consideration of issuing this permit for this large amount of animals.


