



# Enforcement Report to the Commission for July 2009 FY09 Year-to-Date Totals


**\*Number of NOVs**




**Number of Effective Orders**




**Assessed Penalties**

For fiscal year 2009 through July, TCEQ has:

- Issued \*9,334 Notices of Violation
- Issued 1,584 Administrative Orders (see <http://www5.tceq.state.tx.us/eenf/>);
- Assessed \$21,021,549 in administrative penalties;
- Approved 249 Supplemental Environmental Projects; and
- Reduced backlogged cases to 162.

Judgments have been received on 21 cases referred by TCEQ to the Attorney General and the AG has 193 TCEQ cases pending. AG actions typically take from 6 months to 5 years from referral to judgment. For a complete list of court orders from TCEQ referrals, go to:
